Knitted ready-made garments (slip, men's boxers, boxer briefs, trunks, bra, sports bra, panty, string/thong, camisole/undershirt/tank top, hipster, nightwear, bikini, brazilian slip, swimwear, bandeau, ladies top, nursing bra/maternity bra, top, leggings) made of 100 % CO, CO/EL, CO/CMD, CO/PES, CO/PES/EL, CV/EL, 100 % PES, PES/EL, PA/EL (PA/EL including flock, mesh and lace fabric), PA/PES/EL white & dyed, CO/CV & CO/CV/EL in grey melange; all over acid print on PA/EL; all over pigment print on 100 % CO, CO/EL, pigment and rubber print on 100 % CO, CO/EL & CO/CV/EL in grey melange as well as PES/EL, disperse dyed and printed, including accessories (sewing and filament thread, bra cup made of PUR foam in white or black laminated with white or dyed knitted fabric made of PES, heat transfer print, woven label, printed satin label, taffeta label, satin ribbon bow/tape, elastic tape, rubber band, woven tape, elastic band with silicone coating, pendant, lace, mesh/net fabric, hook & eye, wire piping, plastic buckle and closure, metal and plastic bone, PES button, metal & synthetic ring & adjuster with butterfly hanger, metal bra cup/wire); produced by using materials certified according to STANDARD 100 by OEKO-TEX®.

The results of the inspection made according to STANDARD 100 by OEKO-TEX®, Appendix 4, **product class II** have shown that the above mentioned goods meet the human-ecological requirements of the STANDARD 100 by OEKO-TEX® presently established in Appendix 4 for products with direct contact to skin.

The certified articles fulfil requirements of Annex XVII of REACH (incl. the use of azo colourants, nickel release, etc.), the American requirement regarding total content of lead in children's articles (CPSIA; with the exception of accessories made from glass) and of the Chinese standard GB 18401:2010 (labelling requirements were not verified).

The holder of the certificate, who has issued a conformity declaration according to ISO 17050-1, is under an obligation to use the STANDARD 100 by OEKO-TEX® mark only in conjunction with products that conform with the sample initially tested. The conformity is verified by audits.
